# **Notice of Privacy Practices**

This notice describes how medical information about you may be used and disclosed and how you can get access to this information.

<ul> <li>When it comes to your health information, you have certain rights. This section explains your rights and some of our responsibilities to help you.</li> <li>Get an electronic or paper copy of your medical record <ul> <li>You can ask to see or get an electronic or paper copy of your medical record and other health information we have about you. Ask us how to do this.</li> <li>We will provide a copy or a summary of your health information, usually within 30 days of your request. We may charge a reasonable, cost-based fee.</li> </ul> </li> </ul>	<ul> <li>In these cases we never share your information unless you give us written permission:         <ul> <li>Marketing purposes</li> <li>Most sharing of psychotherapy notes</li> <li>Sale of your information</li> </ul> </li> <li>In the case of fundraising we may contact you for fundraising efforts, but you can tell us not to contact you again.</li> <li>Our Uses and Disclosures</li> <li>We typically use or share your health information in the following ways.</li> <li>We can use your health information and share it with other professionals who are treating you.</li> <li>We can use and share your health information to run our practice, improve your care, and contact you</li> </ul>
<ul> <li>Ask us to amend your medical record</li> <li>You can ask us to amend health information about you that you think is incorrect or incomplete.</li> <li>Ask us how to do this.</li> <li>We may say "no" to your request, but we'll tell you why in writing within 60 days.</li> </ul>	when necessary. We can use and share your health information to bill and get payment from health plans or other entities.
<ul> <li>Request confidential communications</li> <li>You can ask us to contact you in a specific way (for example, home or office phone) or to send mail to a different address.</li> </ul>	Electronic Exchange. <ul> <li>We will say "yes" to all reasonable requests.</li> <li>Ask us to limit what we use or share</li> <li>You can ask us not to use or share certain health information for treatment, payment, or our operations. We are not required to agree to your request, and we may say "no" if it would affect your</li> </ul>	How else can we use or share your health information? We are allowed or required to share your information in other ways – usually in ways that contribute to the public good, such as public health and research. <ul> <li>care.</li> <li>If you pay for a service or health care item out-of-pocket in full, you can ask us not to share that information for the purpose of payment or our operations with your health insurer. We will say "yes" unless a law requires us to share that information.</li> </ul>	<ul> <li>Help with public health and safety issues</li> <li><u>We can share health information about you for certain situations such as:</u></li> <li>Preventing disease • Preventing or reducing a serious threat to anyone's health or safety</li> <li>Helping with product recalls • Reporting suspected abuse, neglect, or domestic violence</li> <li>Reporting adverse reactions to medications • Do research • Comply with the law</li> </ul>

#### Get a list of those with whom we've shared information

You can ask for a list (accounting) of the times we've shared your health information for six years prior to the date you ask, who we shared it with, and why.

• We will include all the disclosures except for those about treatment, payment, and health care operations, and certain other disclosures (such as any you asked us to make). We'll provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.

Get a copy of this privacy notice - You can ask for a paper copy of this notice at any time.

#### Choose someone to act for you

• If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your health information. We will ensure the person has this authority before we take any action.

#### **Your Choices**

For certain health information, you can tell us your choices about what we share. If you have a clear preference for how we share your information in the situations described below, talk to us. Tell us what you want us to do, and we will follow your instructions.

In these cases, you have both the right and choice to tell us to:

- Share information with your family, close friends, or others involved in your care
- Share information in a disaster relief situation

If you are not able to tell us your preference we may go ahead and share your information if we believe it is in your best interest. We may also share your information when needed to lessen a serious and imminent threat to health or safety.

• Respond to organ and tissue donation requests • Work with a medical examiner or funeral director. We will share information about you if state or federal laws require it, including with the Department of Health and Human Services if it wants to see that we're complying with federal privacy law.

#### We can use or share health information about you:

- For workers' compensation claims For law enforcement purposes or with a law enforcement official
- With health oversight agencies for activities authorized by law
- For special government functions as military, national security, and presidential protective services
- Respond to lawsuits and legal actions

#### **Our Responsibilities**

- We are required by law to maintain the privacy and security of your protected health information.
- We will let you know promptly if a breach occurs that may have compromised the privacy or security of your information.
- We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or share your information other than as described here unless you tell us we can in writing. If you tell us we can, you may change your mind at any time. Let us know in writing if you change your mind.
